Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Findings: During the inspection, it was determined the gate used were not safe as noted in number 1 below:

During the inspection it was determined that there was a metal baby gate that was not anchored and was leaning up against the wall in the hallway going to the child care restroom area which may threaten the children in care safety, or well being. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule."
