Code: The program is required to protect children from any items and conditions which threaten their health, safety, and well-being.

Findings: Children in care shall be protected from any items and conditions which threaten their health, safety, and well-being. During the inspection, it was determined the knife drawer located in the kitchen was not secured. Any hazardous equipment must be removed, replaced, or repaired and any hazardous condition must be corrected and must be made inaccessible to children. Provide staff training. Submit the program's corrective action plan, which includes a statement that the item or condition has been removed and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

Code: The program is required to have running water below the temperature of 120 degrees Fahrenheit.

Findings: During the inspection, it was determined the water temperature was 138 degrees in the bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to refrain from using and storing outdoor machinery around children.

Findings: During the inspections, Lysol cleaning spray was found on the kitchen counter which the state considers accessible to children. The potentially hazardous substance was determined to be accessible to children in the kitchen

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
