4. The toilet cleaning brush was accessible to the children.
5. The plunger was accessible to the children.
6. The toilet was not flushed.
7. The trash was not emptied from the day before.
8. There was a strong urine odor.

Findings: During the inspection, it was determined that the program's weekly menu did not meet the requirement as noted in numbers 1 & 3 below.

1. The menu was not posted. (No menu for Saturdays or Sundays)
2. The posted menu was not in a visible place readily accessible to parents.
3. The menu was not currently dated.
4. The entire menu was substituted.
5. At least one item on menu did not match what was served.
6. The meal or snack served did not match the posted menu.
