- 1. There was no liquid soap.
- 2. There was no toilet tissue.
- 3. There were no individually assigned towels or disposable towels.
- 4. The toilet cleaning brush was accessible to the children.
- 5. The plunger was accessible to the children.
- 6. The toilet was not flushed.
- 7. The trash was not emptied from the day before.
- 8. There was a strong urine odor.

Findings: During the inspection, it was determined that the following equipment was not being used in accordance with the manufacturer's guidelines the high chairs straps were not being used when child was placed in chair. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
