Findings: During the inspection, it was determined that the Type B Home did not have a working carbon monoxide detector on the main level. A working carbon monoxide detector must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations. Submit the program's corrective action plan to verify compliance with this rule.

Findings: During the inspection, it was determined that surge protectors or outlets did not have childproof receptacle covers. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to refrain from using and storing outdoor machinery around children.
