Findings: During the inspection, it was determined the water temperature was 128 degrees in the bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to safely store food.

Findings: During this inspection, it was determined the refrigerator did not maintain a temperature of 40 degrees Fahrenheit or below

Findings: During the inspection, it was determined that the provider did not have hours of operation posted in a visible place.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to meet the health training requirements.

Findings: In review of records, it was determined the provider did not have current valid documentation for child abuse or communicable disease trainings.
