Code: The program staff is required to protect the children from hazardous conditions in the outdoor play area.

Findings: During the inspection, it was determined that the following hazardous conditions existed in the outdoor play area, as noted in numbers 9, 10, 11 below:

- 1. There was broken glass.
- 2. There were tall weeds.
- 3. There was poison ivy.
- 4. There were tree branches.
- 5. There was mold visible.
- 6. The sandbox was contaminated.
- 7. There were thistles with prickers.
- 8. There were bird droppings.
- 9. The sidewalk in front of the driveway is chopped up and a tripping hazard.
- 10. Front yard full of debris(leaves)
- 11. Nails sticking out of ramp which is connected to the front door

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Findings: During the inspection, it was determined that the program's infant daily care did not meet the requirements of this rule as noted in number 3 below:



1. Infants could not safely and comfortably sit, crawl, toddle, or walk and play according to the infant's stage of development;

2. Infants were not removed from the crib, swing, infant seat, exercise seat or other equipment throughout the day for individual attention;

3. Each non-crawling infant was not provided the opportunity for tummy time each day;
