Findings: During the inspection, it was determined the program did not follow regulations and/or safety precautions when children were transported as noted in number(s) 3 below:

1. Seat belts were not used by children.
2. Child restraint systems were not used.
3. Children were riding in seats that were not securely anchored.
4. More than one child was strapped in a seat belt.
5. A child under the age of twelve years old rode in the front seat of the vehicle.
6. At least one child or adult was standing or sitting on the floor in a moving vehicle, in that [].
7. Adult(s) in the vehicle failed to wear seat belt(s).
