**Domain: 02 Safe & Sanitary Environment** 

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to store cleaning and sanitizing supplies in a place that is inaccessible to children. Cleaning agents, aerosol cans and chemical substances must be stored in their original container or clearly labeled. School-age children may use cleaning supplies and equipment with adult supervision.

Findings: During the inspection, cleaning and sanitizing equipment and supplies were not used or stored properly as noted in number(s) 14-15 below:

- 1. Cosmetics were accessible to children.
- 2. Disinfecting wipes were accessible to children.
- 3. Fish food was accessible to children.
- 4. Hand lotion was accessible to children.
- 5. Hand sanitizer (for children under 24 months) was accessible to children.
- 6. Laundry detergent was accessible to children.
- 7. Powder dish washing soap was accessible to children.
- 8. Paint cans were accessible to children.
- 9. White out was accessible to children.
- 10. Potting Soil was accessible to children.
- 11. Other potentially hazardous substance was accessible to children.
- 12. Cleaning/sanitizing supplies had not been clearly labeled.
- 13. School-age children were using cleaning supplies, agents and/or equipment without adult supervision.
- 14. Two cans of spray aerosol, with caution to keep out of reach of children, were accessible to children in the owner's bedroom.
- 15. Other: toothpaste, with caution to keep out of reach of children, was accessible to children in the spare bathroom area.

Provide staff training. Submit the program's corrective action plan, which includes a statement that the potentially hazardous substance is no longer accessible to children and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

Code: The program is required to post the fire and weather alert plan with a diagram.

- 1. Fire alert plan, including a diagram indicating evacuation routes leading to a meeting place outside where home staff will care for and account for the children in emergency situation.
- 2. Weather alert plan was missing details.
- 3. Weather alert plan was missing a diagram indicating evacuation routes.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to refrain from using television, computers, or other devices during meals and

snacks.

Code: The program is required to have a completed medical on file for each child.

Findings: In review of of the children's records, it was determined that completed medical statements were not on file, as required, for children listed on the JFS Children's Record Review For Child Care as indicated in number 11 below:

- 7. Medical(s) were missing the signature, business address and telephone number of the physician, physician's assistant(PA), advance practice nurse (APN) or certified

nurse practitioner (CNP) who examined the child

- 8. Medical(s) were missing a record of immunizations the child has had specifying month, day and year
- 9. Medical(s) were missing a statement from the physician, PA, APN, or CNP that the child has been immunized or is in the process of being immunized against the diseases

required by division 5104.014 of the Revised Code and found in appendix A to this rule

10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of

conscience, including religious convictions

11. Medical was missing completion of immunization information as one section, either section B or section C, is required.

Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
