Rule: 5101:2-13-09 Background Checks

Code: The program is required to have background checks for all staff and residents over 18 years of age.

Findings: In review of staff records, it was determined that background checks were not requested for the person(s) listed on the Employee Record Chart as noted in number 2 below for Bertha Clark, resident:

Findings: During the inspection, it was determined that the required drills were not completed for item number(s) 1,2, 3 (were not posted at the time of inspection, were provided via e-mail after worker left the home) below:

1. Monthly fire drills

3. Emergency/lockdown drills in each quarter of the calendar year

Rule: 5101:2-13-24 On-site Pools

Code: The provider and program staff are required to make pools on the premises inaccessible to children.

Findings: During the inspection, it was determined a pool was located on the premises and was accessible to children in care as there was no physical barrier as outlined in rule in that the solar cover on the pool does not meet the standards of a manufacture safety label attached, ability to hold a weight of 485 pounds and prevents water from collecting on the cover surface. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
