Findings: During the inspection, it was determined that the following hazardous conditions existed in the outdoor play area, as noted in number(s) [] below:

Findings: During the inspection, it was determined a pool was located on the premises and was accessible to children in care as there was no fence or physical barrier as outlined in rule in that the above ground pool has a 4 foot high door/gate which is locked from the inside which prevents access to the steps to the entrance of the pool however the back side of the pool has a 3 foot height and the other side has a 2 foot height which could be accessible to children.
