Rule: 5101:2-13-09 Background Checks

Code: The program is required to receive a preliminary approval from ODJFS prior to allowing an individual to engage in assigned duties or be near children.

Findings: In review of the staff records, it was determined that background checks were not updated every five years for the provider. Provider's background check expired on 9/7/23.

Submit the program's corrective action plan, which includes a copy of the JFS 01176, or a copy of the preliminary approval or a statement that the individual(s) are no longer engaged in assigned duties and are not near children until the preliminary approval has been received, to the Department to verify compliance with the requirements of this rule.

Rule: 5101:2-13-04 Fire Safety for Type B Homes

Code: The program is required to maintain smoke alarms in the appropriate areas of the program building.

Findings: During the inspection, it was determined that the Type B Home did not have a working smoke alarm on the entry (lower level) of home. A working smoke alarm must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations. Submit the program's corrective action plan to verify compliance with this rule.

Findings: During the inspection, it was determined that written instructions for feeding the infants noted on the Children Record Review form were not on file for Jakari, as required by this rule. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Findings: In review of the children's records, it was the JFS 01234 "Child Enrollment and Health Information For Child Care", was not updated by the administrator and parent on the last page for Kashmere and Kathia.
