Findings: During the inspection, it was determined the handwashing requirements were not being followed by the provider and children in care at the program, in that after returning inside after outdoor play child's hands were not washed and neither was the provider's hands washed after returning from outside. Rule: 5101:2-13-21 Sanitary Environment and Hygiene Code: The program is required to provide children with hygiene items if the child has a bedtime routine occurring at the program.

Findings: During the inspection, it was determined that the children who are enrolled during nontraditional hours were not provided with individual washcloths, towels, toothbrushes, as required. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
