Code: The program is required to have running water below the temperature of 120 degrees Fahrenheit.



Findings: During the inspection, it was determined the water temperature was 128 degrees in the bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to refrain from using and storing outdoor machinery around children.

Findings: During the inspections, baking soda was found in the bathroom cabinet. If swallowed in large amounts this could pose a threat to children. Please keep locked up or out of reach.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
