Findings: During the inspection, it was determined the handwashing requirements were not being followed by the children in care at the program, in that 2 school age children did not wash their hands before leaving for school. Findings: During the inspection, it was determined the program's written disaster plan did not meet the requirement or was missing the information in numbers 1-19 below:

- 17. Training of staff or reassignment of staff duties as appropriate
