**Findings:** During the inspection, it was determined that the Type B Home did not have a working smoke detector where care is provided in accordance with manufacturer's recommendations. A working smoke detector must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations. 10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
