Code: The program is required to receive a preliminary approval from ODJFS prior to allowing an individual to engage in assigned duties or be near children.

Findings: In review of the staff records, it was determined that background checks JFS 1176s were not on file for Javion and Ms. Phillips. Upon further review, Javion background check FBI check was not processed due to the wrong code being used. The provider completed the background check but the JFS 1176 was not on file yet from her request.
