Code: The provider is required to maintain current employee, child care staff members and resident records in the Ohio Professional Registry.

Findings: During the inspection, it was determined that employment records in the Ohio Professional Registry (OPR) were not created or maintained as noted in numbers below

1. Neghesti and Yemane profile were both incomplete. They are missing start date, role, role date, position, and position date.
2. The programs organization dashboard was blank, as both Yemane and Neghesti were not appearing on the dashboard.

Code: The program is required to meet the health training requirements.

Findings: In review of records, it was determined Yemane did not have current valid documentation for communicable disease and child abuse training.

Hours will be verified as completed before I approve this correction.
