Rule: 5101:2-13-12 Safe Environment

Code: The program is required to store cleaning and sanitizing supplies in a place that is inaccessible to children. Cleaning agents, aerosol cans and chemical substances must be stored in their original container or clearly labeled. School-age children may use cleaning supplies and equipment with adult supervision.



Findings: During the inspection, cleaning and sanitizing equipment and supplies were not used or stored properly as noted in number(s) [] below:

11. Other potentially hazardous substance, Shampoo labeled "Keep out of reach of children", was accessible to children in the Restroom area.

22. Other The vacuum cleaner and a broom and dustpan were left in the kitchen area in the open.

Code: The program staff is required to protect the children from hazardous conditions in the outdoor play area.

Findings: During the inspection, it was determined that the following hazardous conditions existed in the outdoor play area, as noted in numbers 9 and 15 below:

9. The outdoor area was littered with trash. There were two larger pieces of trash in the outdoor play area.

15. Other There were several holes dug by the family dog in the walkway to and from the home to the play area.

Rule: 5101:2-13-16 First Aid Kit/Standard Precautions

Code: The program is required to meet the requirements for first aid kits.

Findings: During the inspection, it was determined that the program did not have a first aid kit [onsite/ on the vehicle/ on a field trip] as required, that included all items listed in the appendix A of the rule. The kit(s) were missing the item(s) or the item(s) were not replaced after use and/or expired listed in number(s) 8 and 9 below:

- 8. Tooth preservation system or fresh chilled liquid milk in which to transport a lost permanent tooth, including a written reference indicating location of the refrigerator/freezer where milk is stored if a tooth preservation system is not part of the first aid kit (for programs serving school age children only);
- 9. A working digital thermometer; The battery was dead in the digital thermometer

Correct the violation and submit the program's corrective action plan to verify compliance with the requirements of this rule.
