Rule: 5101:2-13-04 Fire Safety for Type B Homes

Code: The program is required to refrain from blocking escape routes.

Findings: During the inspection, it was determined the program's alternate escape route was blocked. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-12 Carbon Monoxide Detectors - Type B Only

Code: The program is required to meet all requirements for carbon monoxide detectors.

Findings: During the inspection, it was determined that the Type B Home carbon monoxide detector was chirping on the main level of the home. A working carbon monoxide detector must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations. Findings: In review of of the children's records, it was determined that completed medical statements were not on file, as required, for children enrolled. Miracle was missing both a record of immunizations and the JFS 1305 Medical statement. The other children just needed the JFS 1305 Medical statement cover page. Marveah is 5 years old and does not need one at all.
