Rule: 5101:2-13-12 Safe Environment

Code: The program is required to have running water below the temperature of 120 degrees Fahrenheit.



Findings: During the inspection, it was determined the water temperature was 145 degrees in the following rooms bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-13 Smoke Free

Code: The program is required to refrain from exposing children to smoking paraphernalia.

Findings: During the inspection, it was determined that children had access and/or were exposed to smoking paraphernalia as noted in the following numbers 1 and 4 below:

Findings: During the inspection, it was determined that a pet at the program posed a threat to the safety or health of the children, in that children exposed to pet's urine and/or feces. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Code: The program is required to complete and document the required drills.

Findings: During the inspection, it was determined that the required drills were not completed for item numbers 1, 2 and 3 below:

3. Emergency/lockdown drills in each quarter of the calendar year

Code: The program is required to provide mattresses that are covered with a waterproof material that is free of rips or tears.

Findings: During the inspection, it was determined the mattress was not covered with a waterproof material that is free of rips or tears. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-23 Diapering

Code: The program is required to use a disposable separation material during diaper changes.

Findings: During the inspection, it was determined that the staff did not use a/discard separation material between each diaper change, as required by the rule, at the infant/toddler diaper changing station. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Code: The program is required to have the current licensing rules available in a noticeable area on the premises.

Rule: 5101:2-13-15 Child Medical and Enrollment Records

Code: The program is required to have a completed medical on file for each child.



Findings: In review of of the children's records, it was determined that completed medical statements were not on file, as required, for children listed on the JFS Children's Record Review For Child Care as indicated in numbers 2 below

:

1. No medical was on file for at least one child
2. Medical(s) on file was not updated every 13 months

9. Medical(s) were missing a statement from the physician, PA, APN, or CNP that the child has been immunized or is in the process of being immunized against the diseases required by division 5104.014 of the Revised Code and found in appendix A to this rule
10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
