Code: The program is required to maintain a record of the arrival and departure of each child. The program is also required to retain the original attendance record at the program for a period of one year.

Findings: During the inspection, it was determined the program attendance was not done upon arrival of children. All attendance must be done upon arrival and departure of children. It was also noticed that the children were not being tapped in on Kinder Connect in live time. Children must be tapped in on here upon arrival and departure along with the written attendance being done then too.

Rule: 5180:2-13-14 Vehicle Inspections

Code: The program is required to complete and document weekly vehicle inspections.

Findings: During the inspection, it was determined that the program had not performed weekly inspections of vehicles used for transporting children in live time. This must be done weekly and can not be completed in advance.

Code: The program is required to provide a daily written record for each infant in care to the parents when picking up the infant each day.

Findings: During the inspection, it was determined that the written record used to document infant routines and activities was not completed in live time. All activities must be listed as soon as it is completed.

Findings: During the inspection, it was determined that employment records in the Ohio Professional Registry (OPR) were not created or maintained. Rasheda Murphy needs removed from Occra dashboard.
