Findings: Children in care shall be protected from any items and conditions which threaten their health, safety, and well-being. During the inspection, it was determined the program did not protect children from an unsafe item or condition or equipment due to the following number(s) [] below:

1. Pull cord(s) on the window blind(s).
2. Vacuum cord wrapped loosely around vacuum stored in nap room, in reach of children, attached to an object that could result in a severe injury if pulled.
3. Stacked tables.
4. Folding tables.
5. Matches and/or a lighter.
6. Power tool(s).
7. Live wires.
8. Stove(s) that are either on or able to be turned on by a child.
9. Asbestos.
10. Traffic.
11. A body of water.
12. A well.
13. Environmental hazard(s) confirmed by local authorities having jurisdiction over the hazard.
14. A crockpot used to heat bottles.
15. Immediate access to a knife.



16. Large or heavy pieces of shelving units are not securely anchored to the wall.

Any hazardous equipment must be removed, replaced, or repaired and any hazardous condition must be corrected and must be made inaccessible to children. Provide staff training. Findings: During the inspection, it was determined that the outlet in the playroom did not have a wall plate cover and is accessible to children. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

During the inspection, it was determined that children were not protected from the following item or condition which may threaten their health, safety, or well being as noted in the following number 9 below:

1. Telephone cords;
2. Stacked chairs;
3. Employee(s) purse(s);
4. Diaper bags;



5. Television not securely anchored;
6. Small or lightweight pieces of shelving units are not securely anchored to the wall;
7. Staff member stepped over a barrier/gate while holding a child;
8. Chipping or peeling paint;
9. Lock/latch on drawer in kitchen where knives are stored no longer works.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
