Rule: 5101:2-13-12 Carbon Monoxide Detectors - Type B Only

A working carbon monoxide detector must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations. **Rule: 5101:2-13-03 Inspection Requirements**

**Code:** The program is required to have attendance records with the required information.

4. The child's weekly schedule;
5. The time (hours and minutes) of each child's arrival and departure to the program, including transportation by the program.
