Findings: During the inspection, a potentially hazardous item or toxic substance was found in the outdoor play area. Four hazardous items were found (Lawn mower, weed eater, two gas cans, and lighter two bottles of lighter fluid.

Provide staff training. Submit the program's corrective action plan, which includes a statement that the potentially hazardous substance or item is no longer accessible to children and/or children will not be outside when machinery is in use and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
