Findings: During the inspection, it was determined [7] children with [2] under two years of age were in the care of one child care staff member which resulted in more than [six children/three children under two years of age]. 10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
