**Domain: 02 Safe & Sanitary Environment**

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to have running water below the temperature of 120 degrees Fahrenheit.

Findings: During the inspection, it was determined the water temperature was 130 in the bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

**Domain: 08 Staff Files**

Rule: 5101:2-13-07 Staff Records

Code: The provider is required to maintain current employee, child care staff members and resident records in the Ohio Professional Registry.

Findings: During the inspection, it was determined the provider had not created or updated the program's organizational dashboard in the OPR. Both provider and resident need added to the OCCRA dashboard.

Code: The program is required to have a completed medical on file for each child.

Findings: In review of the children's records, it was determined that updated medical statement was not on file for Giovanni.

Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

Rule: 5101:2-13-15 Health Conditions

Code: The program is required to have a completed JFS 01236 "Medical/Physical Care Plan" on file for each condition for each child, which is updated annually and retained for at least one year.

Findings: In review of records, it was determined the JFS 01236 "Medical/Physical Care Plan for Child Care" had not been updated annually. Ensure both parent and provider update this annually.

Submit the corrective action plan to the Department to verify compliance with the requirements of this rule.

Rule: 5101:2-13-25 Medication Requirements

Code: The program is required to discard or return medication, medical foods, and/or topical products that are no longer being administered or have expired. The program is also required to maintain current documentation to administer medication, medical foods, and topical products.

Findings: During the inspection, it was determined medication for Ethan had expired in January 2024.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
