Findings: During the inspection, it was determined the handwashing requirements were not being followed by the provider, program staff, residents, or a child in that upon a child's arrival, the child was not instructed to wash her hands.. - 11. The trash was not emptied from the day(s) before.
- 12. The trash can was overflowing with trash.
- 13. The trash can was infested with insects.
- 14. The trash can was visibly dirty.
- 15. Accessible ladders in the outside play space.
