Code: This rule requires that the disposal of materials that contain blood are done by the use of a sealable, leakproof plastic bag or by double bagging in plastic bags that are securely tied.

Findings: During the inspection, it was observed that materials that contain blood are not disposed of by using of a sealable, leakproof plastic bag or by double bagging in plastic bags that are securely tied in that paper towels used for bloody nose were disposed of directly in the common trash container.

Domain: 05 Health & Safety

Rule: 3301-37:06 Safe handling, storage, and disposal of bio-contaminants

Code: This rule requires that disposable gloves be worn during contact with blood or bodily fluids which contain blood, such as vomit or feces in which blood can be seen.

Findings: During the inspection, it was observed that disposable gloves were not worn during contact with blood or bodily fluids which contain blood, such as vomit or feces in which blood can be seen in that the teacher assisted with a bloody nose and did not wear gloves.
