Findings: During the inspection, it was determined the following requirement was not met: Medication was expired. Childs name was not on medication.

- Child's information, medication name, or dosage information was missing
- Medication was not in original container or the container from which it was dispensed
- Medication was expired.

Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in ratio is obligated to have evidence of a signed medical statement on or before the first day of employment.
