Findings: During the inspection, the preschool special education program did not meet requirements of section 3323.022 of the Revised Code and rule 3301-51-11 of the Administrative Code.

Classroom 130am was identified as an integrated classroom however, 7 children with a disability and 6 typical children are enrolled.
