Rule: 3301-37:04 Ratio and Group size: Special education classroom

Code: This rule requires the staff ratio of one teacher for every eight children to be maintained at all times with a center-based teacher, and a second adult shall be present when there are nine or more children, including nondisabled children enrolled in a class session.

Findings: During the inspection, the staff/child ratio for a special education classroom was not maintained.
