**Low Risk Non-Compliances**

**Domain: 07 Diapering & Infant Care**

Rule: 3301-37:09 Infant food or formula requirements

Code: This rule requires breast milk provided by the parent or guardian, shall be labeled with the child's name, date expressed, date of receipt, and shall be immediately refrigerated. Formula provided by the parent shall be labeled with the child's name, the date of receipt, and immediately refrigerated. Breast milk or formula shall not be stored for more than twenty-four hours

Findings: During the inspection, breast milk and formula provided by the parent was not labeled appropriately.

**Domain: 10 Written Policies & Procedures**

Rule: 3301-37:07 Safe sleep policy

Code: This rule requires all preschool programs are to comply with the Ohio department of health safe sleep procedures.

Findings: During the inspection, it was determined that the written safe sleep policy did not include compliant safe sleep procedures. Additionally, the program was not complying with the Ohio Department of Health safe sleep procedures in that stuffed animals were observed in cribs and a mattress wedge was observed without written instruction.
