#### Domain: 02 Safe & Sanitary Environment

Rule: 5180-37:06 Cleaning and sanitizing supplies

Code: This rule requires that cleaning and sanitizing supplies shall be stored in a space that is inaccessible to children. Cleaning agents, aerosol cans and all other chemical substances are to be stored in a designated area in their original containers and/or clearly labeled.

Findings: During the inspection, it was observed that cleaning and sanitizing supplies stored in a space that is accessible to children. (Windex and Swiffer pads in child restroom and disinfecting wipes in classroom.) (Child inhaler also accessible to children in kitchen.)

### Low Risk Non-Compliances

#### Domain: 03 Postings & Equipment

Rule: 5180-37:07 Emergency procedure postings and records

Code: This rule requires posting procedures for emergency situations, including fire drills, rapid dismissals and tornado drills and keeping records of such drills or dismissals.

Findings: During the inspection, it was determined that policies did not require keeping records of emergency drills or dismissals. (Tornado and lockdown drills.)

#### Domain: 04 Indoor/Outdoor Space

Rule: 5180-37:05 Outdoor play space

Code: This rule requires that the play area be well defined to protect children from traffic, animals, or other hazards.

Findings: During the inspection, it was observed that the play area was not well defined to protect children from traffic, animals, or other hazards. (Grassy space and pavement in parking lot used and does not protect children from traffic.)

#### Domain: 08 Staff Files

Rule: 5180-37:04 Staff with required health and safety trainings

**Code:** This rule requires the program to ensure the following each staff member has completed and is current with an approved course for age-appropriate first aid and CPR in accordance with rule 5101:2-12-10 of the Administrative Code.

**Findings:** During the inspection and review of staff files, at least one person onsite does not have a current age appropriate course in CPR from an approved provider.

#### **Domain: 08 Staff Files**

**Rule:** 5180-37:04 Staff with required health and safety trainings

**Code:** This rule requires the program to ensure each staff member has completed and is current with an approved course for age-appropriate first aid and CPR in accordance with rule 5101:2-12-10 of the Administrative Code.

**Findings:** During the inspection and review of staff files, at least one person onsite does not have a current age appropriate course in first aid from an approved provider.

#### **Domain: 09 Children's Files**

**Rule:** 5180-37-08 Medication authorization

**Code:** This rule requires that the program secure and have on file all required information no later than the first day of attendance unless otherwise required. The health record of each child shall include but not be limited to the physician's or dentist's authorization and written instructions to administer prescription medication, medical food, modified diet, or fluoride supplement to a child enrolled in the program.

**Findings:** During the inspection, and a review of children(s) files, it was determined that the health record of each child did not include physician's or dentist's medication authorization and written instructions.
