Findings: During the inspection, it was observed that an aerosol spray was stored in a space that is accessible to children.

Rule: 3301-37:06 Infant sleeping placement

Code: This rule requires that Infants be placed in their cribs for sleeping, and shall not be allowed to sleep in car seats, swings, mesh cribs, playpens, bassinets of any type, or other equipment.

Findings: During the inspection, it was observed that an infant was not placed in their crib for sleeping, and /or allowed to sleep in car seats, swings, mesh cribs, playpens, bassinets, or other equipment.

Rule: 3301-37:05 Center cleaning and sanitizing

Code: This rule requires that the center be cleaned daily and kept in a sanitary condition at all times. Cleaning and sanitizing is not to take place while rooms are occupied by children, except for general cleanup activities such as sweeping, vacuuming, mopping and wiping off tables which are part of the daily routine.

Findings: During the inspection, it was observed that the center restroom is not cleaned daily and kept in a sanitary condition at all times.
