Rule: 3301-32:03 Required background checks

Code: This rule requires a director and preschool staff member to provide evidence of criminal record checks and five-year updates that meet the background check requirements as prescribed in rule?5101:2-12-09?of the Administrative Code and the Child Care and Development Block Grant Act of 2014, 42 U.S.C. 9858 (CCDBG Act of 2014) for programs contracted to provide publicly funded child care services and department licensed head start programs. Documentation that reports and five-year updates are sent to the district or the department's office of educator licensure as required by section?3319.391?of the Revised Code shall be kept on file.

Findings: During the inspection and review of staff files, background checks to meet the Child Care and Development Block Grant (CCDBG) for programs serving children under publicly funded child care or head start were not updated every five years. One staff member had additional background checks were expired.

Low Risk Non-Compliances

Domain: 05 Health & Safety

Rule: 3301-32:10 Emergency drill practice

Code: This rule requires children shall have drill practice at least once per quarter during the school year and at least once during a summer program to demonstrate appropriate procedures and appropriate behavior in accordance with the programs written policy and procedures during an emergency regarding the rooms where the program is provided.

Findings: During the inspection, the program did not have documentation of emergency drill practice at least once quarterly. Only the 2021-22 school year was verified.

Domain: 06 Program Information

Rule: 3301-32:05 Written philosophy and goals

Code: This rule requires a school child program to have daily plans that provide a balance to the academic emphasis of the regular school day.

Findings: During the inspection, the daily plans designed to show a balance to the academic emphasis of the regular school day. Two teachers did not have daily plans available for review.



Domain: 09 Children's Files

Rule: 3301-32-06 Individual child transportation plan

Code: This rule requires that the individual child transportation plan include a mutual agreement and consent between the program coordinator and the child's parents allowing a school child to leave the school child care program for specific activities.

Findings: During the inspection and review of children's files, it was determined that the individual child transportation plan did not include a mutual agreement and consent between the program coordinator and the child's parents allowing a school child to leave the school child care program for specific activities. Transportation plans signed by parents for children leaving for sports were not verified.
