Code: This rule requires there be enough preschool staff members readily accessible within the building in which the program is located to ensure that the maximum number of children per preschool staff member as required by paragraph (N) of this rule is met at all times.

Findings: During the inspection there were sufficient staff present, however, the use of cardboard dividers kept staff from properly supervising the children during naptime.
