Findings: A child was reported or observed left alone or unsupervised. A kindergarten child walked a group of 5 preschoolers from the downstairs to the kindergarten classroom without a teacher present.

### **Moderate Risk Non-Compliances**

#### Domain: 01 Ratio & Supervision

Rule: 3301-37:04 Staff/child ratio maintained at all times

Code: This rule requires the preschool staff member/child ratio to be maintained at all times and sufficient individuals must be physically present with the children in accordance with section 3301.56 of the Revised Code.

Findings: During the inspection, individuals were not physically present with children to maintain ratio at all times. A ratio of 1 staff member to 19 children was observed when the preschool group was mixed with the kindergarten classroom.
