Consistent with requirements as established by section 3319.073 of the Revised Code, such staff shall complete at least four hours of in-service training in child abuse recognition and prevention within two years of employment and every five years thereafter.

Findings: During the inspection and review of staff files, at least one staff member had not completed a course on the recognition and prevention of child abuse from an approved provider within 60 days of hire.
