**Domain: 03 Postings & Equipment**

Rule: 3301-32:04 Phone requirements

Code: This rule requires phone numbers for emergency services as locally appropriate must be posted in a visible location readily accessible to the appropriate program personnel in the area.

Findings: During the inspection, phone numbers for emergency services were not posted in a visible location and accessible for staff.

**Domain: 08 Staff Files**

Rule: 3301-32:03 Staff with required health and safety training

Code: This rule requires the program to ensure each staff member shall have current valid age appropriate first aid, age appropriate CPR, child abuse recognition and prevention, and management of communicable disease certification in accordance with rule 5101:2-12-10 of the Administrative Code. In-service training on age appropriate first aid, age appropriate CPR, child abuse recognition and prevention, and management of communicable disease shall be updated according to the length of time required by the approved organization.

Findings: During the inspection and review of staff files, at least one person onsite does not have a current age appropriate course in first aid from an approved provider.

**Domain: 08 Staff Files**

Rule: 3301-32:03 Staff medical statement



Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in ratio is obligated to have evidence of a signed medical statement on or before the first day of employment.

Findings: During the inspection and review of staff files, individuals used to count in ratio did not have evidence of a signed medical statement on or before the first day of employment.

### **Domain: 08 Staff Files**

Rule: 3301-32:03 Staff minimum requirements

Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in the ratio is obligated to have evidence that they have a high school diploma, GED or high school equivalency.

Findings: During the inspection and review of staff files, individuals used in ratio did not have documentation of a high school diploma or equivalent on file and available for review.

### **Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with diarrhea (three or more abnormally loose stools within a twenty-four-hour period) shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Diarrhea (three or more abnormally loose stools within a twenty-four-hour period).

### **Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with difficult or rapid breathing shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: difficult or rapid breathing.



**Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with redness of the eye or eyelid, thick and purulent (pus) eye discharge, matted eyelashes, burning, itching or eye pain shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Redness of the eye or eyelid, thick and purulent (pus) eye discharge, matted eyelashes, burning, itching or eye pain.

**Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with severe coughing, causing the child to become red or blue in the face or to make a whooping sound shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Severe coughing, causing the child to become red or blue in the face or to make a whooping sound.

**Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with sore throat or difficulty swallowing shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, it was determined the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Sore throat or difficulty swallowing.

**Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge





Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with a stiff neck with an elevated temperature shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: A stiff neck with an elevated temperature.

### Domain: 10 Written Policies & Procedures

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with a temperature of one hundred degrees Fahrenheit taken by the auxiliary method when in combination with other signs of illness shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: A child with a temperature of one hundred degrees Fahrenheit taken by the auxiliary method when in combination with other signs of illness shall be immediately isolated and discharged to his parent or guardian.

### Domain: 10 Written Policies & Procedures

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with evidence of untreated lice, scabies, or other parasitic infestation shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Evidence of untreated lice, scabies, or other parasitic infestation.

### Domain: 10 Written Policies & Procedures

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with untreated infected skin patch(es) shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Untreated infected skin patch(es).



**Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with vomiting more than one time when accompanied by any other sign or symptom of illness shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Vomiting more than one time when accompanied by any other sign or symptom of illness.

**Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with yellowish skin or eyes shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: yellowish skin or eyes.

**Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the policy for communicable disease to include isolation and discharge precautions for specific symptoms of children suspected of having a communicable disease.

Findings: During the inspection review it was determined the policy for communicable disease was missing isolation and discharge precautions.

**Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Ill child isolation requirements

Code: This rule requires the communicable disease policy to include the following: made comfortable in a warm, safe environment. All linen and blankets used by an ill child shall be laundered before being used by another child, and cots or recovery/nurse station bed, shall be disinfected.



Findings: During the inspection review, the policy for communicable disease did not include making a child comfortable in a warm

### **Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Ill child isolation requirements

Code: This rule requires the communicable disease policy to include the following: a child isolated due to suspected communicable disease to be within sight and hearing of an adult at all times.

Findings: During the inspection review, the policy for communicable disease was missing the requirement for the isolation space to be within sight and hearing of an adult at all times.

### **Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Ill child isolation requirements

Code: This rule requires the communicable disease policy to include a child isolated due to suspected communicable disease to be observed carefully for worsening condition.

Findings: During the inspection review, the policy for communicable disease did not include the requirement to observe a child showing symptoms of illness.

### **Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with unusually dark urine and/or grey or white stool shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Unusually dark urine and/or grey or white stool.

### **Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Exposure to a communicable disease





Code: This rule requires each program to have a written policy concerning the management of communicable disease. The policy shall include notifying, when aware of diagnoses, all parents when children enrolled are exposed to a communicable disease during program time.

Findings: During the inspection review, the procedures for notifying all parents of exposure to a diagnosed communicable disease was not included in the communicable disease policy.

### **Domain: 10 Written Policies & Procedures**

Rule: 3301-32:08 Communicable Disease Policy: Ill child isolation requirements

Code: This rule requires the communicable disease policy to include the following: a child isolated due to suspected communicable disease to be cared for in a room or portion of a room not being used in the preschool program.

Findings: During the inspection review, the policy for communicable disease was missing the requirement for the room or portion of a room used to isolate an ill child

### **Domain: 10 Written Policies & Procedures**

Rule: 3301-32:10 Ill child policies

Code: This rule requires policies and procedures regarding handling and/or exclusion of ill children and reporting communicable diseases, which includes, but is not limited to, the following: Isolating and excluding an ill child.

Findings: During the inspection and policy review, the program did not have policies regarding isolating and excluding an ill child.

### **Domain: 10 Written Policies & Procedures**

Rule: 3301-32:10 Ill child policies

Code: This rule requires policies and procedures regarding handling and/or exclusion of ill children and reporting communicable diseases, which includes, but is not limited to, the following: Training of staff members on signs and symptoms, handwashing, and disinfecting equipment and materials.

Findings: During the inspection and policy review, the program did not have policies regarding training staff members on signs and symptoms of illness, handwashing, and disinfecting equipment and materials.
