Findings: During the inspection and review of staff files, at least one person onsite does not have a current age appropriate course in CPR from an approved provider. Seven staff members do not have current CPR training.

Findings: During the inspection and review of staff files, individuals used to count in ratio did not have evidence of a signed medical statement on or before the first day of employment. Four staff members did not have medical statements on file.
