## Moderate Risk Non-Compliances

### Domain: 01 Ratio & Supervision

Rule: 3301-37:04 Montessori maximum group size

Code: This rule requires an accredited program that uses the Montessori method endorsed by the American Montessori society ([www.amshq.org](http://www.amshq.org)) or the association Montessori international ([www.montessori-ami.org](http://www.montessori-ami.org)) as its primary method of instruction may combine preschool children of ages three to five years of age with children enrolled in kindergarten. Notwithstanding anything to the contrary in division (B)(2) of section 3301.56 of the Revised Code, when such age groups are combined, the maximum number of children per preschool staff member shall be twelve and the maximum group size shall be twenty-four children.

Findings: During the inspection, an accredited Montessori program with mixed preschool and kindergarten children exceeded the maximum group size of twenty-four children. Four classrooms exceeded the maximum group size of 24. 2 classrooms had 25 enrolled and 2 had 26 enrolled.

## Low Risk Non-Compliances

### Domain: 03 Postings & Equipment

Rule: 3301-37:07 Emergency numbers posting

Code: This rule requires posting emergency numbers by each telephone.

Findings: During the inspection, it was determined that policies did not require posting emergency numbers by each telephone. One classroom did not have emergency numbers posted by the telephone.

### Domain: 03 Postings & Equipment

Rule: 3301-37:07 Medical and dental emergency procedure posting

Code: This rule requires posting medical and dental emergency procedures in each preschool classroom and by each telephone.

Findings: During the inspection, it was determined that policies did not require posting medical and dental emergency procedures in each preschool classroom and by each telephone. One classroom did not have medical and dental emergency procedures posted by the telephone.

### Domain: 07 Diapering & Infant Care



### Rule: 3301-37:12 Soiled diapers storage/laundrying

Code: This rule requires storage and laundrying of soiled diapers to be handled in accordance with the following methods:(1) Diapers or clothing soiled with fecal matter and sent home with a child need not be rinsed at the program facility, but may be placed directly into a container that can be sanitized or bag, sealed tightly, stored away from the rest of the child's belongings and out of the reach of children.(2) Soiled diapers to be disposed of or cleaned by the program shall be placed in a common plastic-lined covered container which shall be emptied, cleaned, and disinfected with an appropriate germicidal agent daily or more frequently as needed. Diapers to be laundered at the program facility should be stored in an appropriate germicidal solution until laundered.(3) Soiled diapers to be commercially laundered shall be held for pickup for laundrying for no longer than seven days (4) Diapers to be laundered at home or by the program shall be held for laundrying for no longer than one day.(5) Soiled disposable diapers shall be discarded daily.

Findings: During the inspection, it was observed that soiled diapers were not properly disposed or handled. Soiled clothing and/or cloth diapers were not sent home daily. One classroom did not have a covered diaper pail.

### Domain: 08 Staff Files

#### Rule: 3301-37:04 Staff with required health and safety trainings

Code: This rule requires the program to ensure the following each staff member has completed and is current with an approved course for age-appropriate first aid and CPR in accordance with rule 5101:2-12-10 of the Administrative Code.

Findings: During the inspection and review of staff files, at least one person onsite does not have a current age appropriate course in CPR from an approved provider. Four staff members did not have an initial or current first aid training.

### Domain: 08 Staff Files

#### Rule: 3301-37:04 Staff Medical statement

Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in ratio is obligated to have evidence of a signed medical statement on or before the first day of employment.

Findings: During the inspection and review of staff files, individuals used to count in ratio did not have evidence of a signed medical statement on or before the first day of employment. Three staff members did not have medical statements on file.

### Domain: 08 Staff Files



Rule: 3301-37:04 Orientation training

Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in ratio is obligated to have an orientation training as prescribed by the department completed within thirty days of the individuals start date.

Findings: During the inspection and review of staff files, individuals used in ratio did not have documentation of the required orientation training prescribed by the department completed within thirty days of the start date. One staff member has not completed the required orientation.

### **Domain: 08 Staff Files**

Rule: 3301-37:04 Staff with required health and safety trainings

Code: This rule requires the program to ensure each staff member has completed and is current with an approved course for age-appropriate first aid and CPR in accordance with rule 5101:2-12-10 of the Administrative Code.

Findings: During the inspection and review of staff files, at least one person onsite does not have a current age appropriate course in first aid from an approved provider. Six staff members did not have an initial or current first aid training.

### **Domain: 09 Children's Files**

Rule: 3301-37-08 Medication authorization

Code: This rule requires that the program secure and have on file all required information no later than the first day of attendance unless otherwise required. The health record of each child shall include but not be limited to the physician's or dentist's authorization and written instructions to administer prescription medication, medical food, modified diet, or fluoride supplement to a child enrolled in the program.

Findings: During the inspection, and a review of children(s) files, it was determined that the health record of each child did not include physician's or dentist's medication authorization and written instructions. Two students had no paperwork for extra medication with albuterol. Two prescriptions were missing labels.
