Classroom 3, T-R-F was identified as an integrated classroom; however, the current enrollment is 4 IEP students and 14 typical peers (total 18 students). Classroom 4, T-R-F was identified as an integrated classroom; however, the current enrollment is 5 IEP student and 12 typical peers (total 17 students).
