#### Domain: 08 Staff Files

Rule: 5180-37:04 Required background checks

Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in ratio is obligated to meet the requirements as prescribed in section 3301.541 of the Revised Code and if applicable, rehabilitation criteria as described in rules 3301-20-01 and 3301-20-03 of the Administrative Code.

Findings: During the inspection and review of staff files, individuals used in ratio did not have evidence of criminal background checks that meet the requirements.

### Low Risk Non-Compliances

#### Domain: 02 Safe & Sanitary Environment

Rule: 5180-37:06 Safe and sanitary equipment and materials

Code: This rule requires that furniture and equipment meet safety and sanitation requirements.

Findings: During the inspection, it was observed that furniture and equipment does not meet safety and sanitation requirements. The safety straps on the changing pad were not used. An area rug in the classroom was buckled, providing a tripping hazard.

#### Domain: 07 Diapering & Infant Care

Rule: 5180-37:12 Soiled diapers storage/laundrying

Code: This rule requires storage and laundrying of soiled diapers to be handled in accordance with the following methods:(1) Diapers or clothing soiled with fecal matter and sent home with a child need not be rinsed at the program facility, but may be placed directly into a container that can be sanitized or bag, sealed tightly, stored away from the rest of the child's belongings and out of the reach of children.(2) Soiled diapers to be disposed of or cleaned by the program shall be placed in a common plastic-lined covered container which shall be emptied, cleaned, and disinfected with an appropriate germicidal agent daily or more frequently as needed. Diapers to be laundered at the program facility should be stored in an appropriate germicidal solution until laundered.(3) Soiled diapers to be commercially laundered shall be held for pickup for laundrying for no longer than seven days (4) Diapers to be laundered at home or by the program shall be held for laundrying for no longer than one day.(5) Soiled disposable diapers shall be discarded daily.

Findings: During the inspection, it was observed that soiled diapers were not properly disposed or handled. The container for soiled diapers was not covered.

**Domain: 09 Children's Files**

Rule: 5180-37-08 List of chronic physical problems and history of hospitalization

Code: This rule requires that the program secure and have on file all required information no later than the first day of attendance unless otherwise required. The health record of each child shall include but not be limited to a list of any chronic physical problems and any history of hospitalization.

Findings: During the inspection, and a review of children(s) files, it was determined that the health record of each child did not include a list of any chronic physical problems and any history of hospitalization.

Code: This rule requires that the program secure and have on file all required information no later than the first day of attendance unless otherwise required. The health record of each child shall include but not be limited to a list of any diseases the child has had.

Findings: During the inspection, and a review of children(s) files, it was determined that the health record of each child did not include a list of any diseases the child has had.

Rule: 5180-37-08 Names and telephone numbers of physician and dentist

Code: This rule requires that the program secure and have on file all required information no later than the first day of attendance unless otherwise required. The health record of each child shall include but not be limited to the names and telephone numbers of physician and dentist in case of emergency.

Findings: During the inspection, and a review of children(s) files, it was determined that the health record of each child did not include the names and telephone numbers of physician and dentist in case of emergency.

**Domain: 09 Children's Files**

Rule: 5180-37-08 Emergency medical and dental care transportation

Code: This rule requires that the program secure and have on file all required information no later than the first day of attendance unless otherwise required. The health record of each child shall include but not be limited to the permission of parent for emergency medical and dental care and transportation as required by section 3313.712 of the Revised Code.



Findings: During the inspection, and a review of children(s) files, it was determined that the health record of each child did not include permission of parent for emergency medical and dental care and transportation.

**Domain: 09 Children's Files**

Rule: 5180-37-08 Cumulative record requirements

The cumulative record of each child shall include but not be limited to the parent authorization for transportation related to the program.
