Serious Risk Non-Compliances

Domain: 01 Ratio & Supervision

Rule: 3301-37:04 Staff/child ratio maintained at all times

Code: This rule requires the preschool staff member/child ratio to be maintained at all times and no child is ever left alone or unsupervised.



Findings: A child was reported or observed left alone or unsupervised. Children were observed in the going back and forth from the classroom and the hallway with no supervision.

Moderate Risk Non-Compliances

Domain: 00 License & Approvals

Rule: 3301-37:02 Program amendment submitted

Code: This rule requires a change of capacity to be submitted prior to children attending.

Findings: Preschool children attended the program prior to a change of capacity being submitted.

Domain: 04 Indoor/Outdoor Space

Rule: 3301-37:05 Infant and non-ambulatory child approved rooms

Code: This rule requires that infants and non-ambulatory children eighteen months of age or older shall receive care in rooms approved for that use by local building, fire officials, and the department prior to use.

Findings: During the inspection, it was observed that children under age 2 1/2 are being cared for in rooms that are not approved by the local building department.

Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in ratio is obligated to meet the requirements as prescribed in section 3301.541 of the Revised Code and if applicable, rehabilitation criteria as described in rules 3301-20-01 and 3301-20-03 of the Administrative Code.

Findings: During the inspection and review of staff files, individuals used in ratio did not have evidence of criminal background checks that meet the requirements.

- Medication was not in original container or the container from which it was dispensed
- Medication was expired.
