Findings: During the inspection, it was observed that cleaning and sanitizing supplies stored in a space that is accessible to children in that disinfecting wipes were on the counter in reach of children in room 801.

Code: This rule requires medication to be administered with policies in place that assure child information is gathered and health professional instructions are followed

- Child's information, medication name, or dosage information was missing
- Medication was not in original container or the container from which it was dispensed
- Medication was expired.
