Findings: During the inspection, it was observed that cleaning and sanitizing supplies stored in a space that is accessible to children. Disinfectant wipes and Lysol spray in 003.

Findings: During the inspection, it was determined that the daily schedule for each age group did not include a balance of both quiet and active play. Not posted in 002A, 002B, 005, 003.

**Domain: 08 Staff Files**

Rule: 5180-37:04 Staff with required health and safety trainings

Code: This rule requires the program to ensure at least one preschool staff member who has completed and is current with a child abuse recognition and prevention course based on an approved curriculum. The child abuse recognition and prevention curriculum used in the course may be consistent with requirements as established by section 3319.073 of the Revised Code or appear on the approved curriculum list posted on the departments website. Consistent with requirements as established by section 3319.073 of the Revised Code, such staff shall

complete at least four hours of in-service training in child abuse recognition and prevention within two years of employment and every five years thereafter.

Findings: During the inspection and review of staff files, at least one person onsite in each classroom does not have a current course on the recognition and prevention of child abuse from an approved provider.
