Findings: During the inspection, it was determined that policies did not require keeping records of emergency drills or dismissals. Documentation of completed lockdown and tornado drills according to the required schedules were not kept on file. (Tornado only completed April and May and Lockdown only completed in November)

#### Domain: 08 Staff Files

Rule: 5180-37:04 Staff Medical statement

Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in ratio is obligated to have evidence of a signed medical statement on or before the first day of employment.
