Findings: During the inspection, a preschool and school age group that was combined at the beginning of the day or the end of the day exceeded twelve children. A school-age child was sent to a preschool room during the school day. The school-age child was left alone in the room.

Findings: During the inspection and review of staff files, individuals used to count in ratio did not have evidence of a signed medical statement on or before the first day of employment. One staff member did not have a current medical statement.
