- Medication was not in original container or the container from which it was dispensed
- Medication was expired.

Findings: During the inspection, breast milk or formula provided by the parent was not labeled or stored appropriately.

Findings: During the inspection and review of staff files, individuals used to count in ratio did not have evidence of a signed medical statement by a licensed physician, physician assistant, advanced practice registered nurse or a certified nurse practitioner.
